Sub: Upgradation of school from Middle to secondary level.
w.e.f. academic session 1987-88 (without-aid).

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi, for the upgradation of the existing Middle school to secondary level with effect from 1987-88 session, subject to the fulfilment of the following terms & conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school will meet the additional liability of secondary classes.
4. That the school shall establish and equip all the Science Labs as per the norms of the Department/CBSE.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added.
6. That adequate sports material shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of section 10(1) of the Delhi School Education Act and Rules, 1973, and payment shall be made through crossed cheques.
8. That the enrolment of each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class-room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of sections should not exceed the number of existing class-rooms of proper size in the school and each class-room, science lab. and library rooms may be fitted with proper electrical appliances.
9. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately. That the school shall

10. That the school shall discontinue with the services of unqualified and over-aged staff, if any, immediately.
11. That the service contract between the Management and the employees shall be executed immediately.
12. That all the facilities prescribed under rule 50 & 51 of the DSER, 1973, shall be made available to the students.
13. That the arrangements for good drinking water shall be available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
14. That the Management of the school shall create a Reserve Fund of Rs.15,000/- (Rupees ^{Ten} ~~Five~~ Thousand) only in the name of the Director of Education & the Manager of the school.
15. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
16. That the school society shall obtain land from the DDA and will construct the building as per the specifications of the department within a period of three years.
17. That the school shall shift its all classes from Ist to X to the new site after getting the land from the DDA and the construction of a suitable building thereon, with the prior approval of the Director of Education, Delhi. The present school will be closed thereafter forthwith.
18. That the provident fund, family pension and group insurance benefits of the employees payable to the employees of a recognised private school, shall be made available to the employees of the school, these benefits shall not be less than those of the employees of the corresponding status in schools run by the appropriate authority.
